- Initial focus on adult criminal justice, then juveniles
- True partnerships between state and local leaders, sincere commitment to improved outcomes




Juvenile Justice Incentive Grant Program

- JJIGP began in '13: used '12 as 'Baseline' year
- Target 30 highest committing counties
- Defined/identified evidence-based programs*
- Provide funding to counties for EBPs based on need
- Allow for innovation (e.g., "Managing Entities")



26 out of 28 grantee courts had a reduction in Out-ot-Home Placements (STP Admissions & Felony Commitments) compared to their FY 2012 baseline.

- Community-Based Service Provider Agencies


Quality Implementation Partnership (QuIP)

Features:


- Engages key leaders, fosters EBP champions
- Recruit and retain an effective workforce
- Emphasis on high-fidelity model implementation
 - Administrative (policies, procedures, practices)
 - Clinical Team
- Builds data systems that tie payment to performance

Preparation

- Preparation of the Agency and Engagement of the Leadership
- Cost/Benefit Analysis
- Conducting the "are we a good fit" assessment surrounding collaborative relationship
- Assessing Stakeholder Relationships
- Planning for Program Sustainability

Domain 2: Agency Functioning

Implementation

- Advocacy and Accountability
- Staff Recruitment, Hiring, and Retention
- Performance based pay linked with quality assurance metrics
- Planning for Yalom's stages of group development within an organization
- Planning to address case failures & conduct case autopsies on unsuccessful cases
- Externship

Domain 2: Agency Functioning

Implementation

- Programmatic Monitoring
 - ► TYPE Reports
 - Company-wide Weekly Operation Calls
 - Collaborative Performance Monitoring & Problem Solving
 - Case Autopsies on Successful Cases
 - Clinician Development Plans

Preparation

- Engagement
 - Clarify standards of evidence
 - Align stakeholder needs with appropriate evidence based program
 - Identify Stakeholder's data & outcome expectations
 - Identify the viability & sustainability of existing and potential funding streams

- Preparation continued
 - Education
 - Engage and inform key stakeholders on the value of evidence based programs expected outcomes and cost benefit
 - Facilitate all required model training
 - Develop and codify eligibility criteria and referral process
 - Develop evidence based program performance benchmarks, data collection and analytics while introducing the concept of data-driven decision making

- Implementation
 - Fostering of EBP Champions
 - Clearly define standard of accountability for providers
 - Promote high level of professionalism, efficiency and client responsiveness
 - Monitor progress against referral and utilization targets
 - Develop mutually consistent formal and informal relationship management with key stakeholders
 - Design and maintain a continuous quality improvement process

Implementation continued

- Fostering of EBP champions
 - Collect, analyze and report data to key stakeholders
 - Issue regular reports and updates to key stakeholders
 - Focus on model fidelity, staff development, program improvement and meeting performance measures
 - Hold providers accountable for high performance outcomes
 - Minimize and eliminate risk of program failure
